| History of the nominated place or object: | From the 1930's until the 1980's this property was the family residence of the Orchard family, and where Dr Barbara Orchard spent her formative childhood, adolescent and early adulthood. Dr Orchard is a trailblazer and advocate for Womens' rights on multiple levels. Firstly, she is a pioneer for women in medicine having completed her medical degree in a time where women were actively discouraged from pursuing a medical career (I believe she was one of only two female graduates in her class at Adelaide University and Flinders University did not have their first female graduates for nearly two decades after this). | | | | |

Secondly, she is a pioneer for women in sport having played cricket at Club, University, State and International level. In addition to this she is a former President of the South Australian Women's Cricket Association and one of only two women appointed to the Life Members of Adelaide University Sports Association since its establishment in 1896.

Thirdly, she is a Trustee of the South Australian Women's

Thirdly, she is a Trustee of the South Australian Women's Memorial Playing Fields Trust, having been involved in their establishment due to her passion for preserving the history of the role of female nurses and their sacrifices during World War II.
